Command Overview

1. This week UKMTO issued one Advisory, see page 3 for full details.

2. It was reported to UKMTO on 28 Aug 17 that, in the Bab el Mandeb straits, four skiffs were sighted, 2 skiffs with ladders. Ref ADVISORY NOTICE 004/AUG/2017. Vessel and crew reported safe.

3. On 04 Sep 17 UKMTO will release a Notice on behalf of CTF151 which advises of a focused operation in the areas off the Somali Coast and Suqutra Gap. This security operation will be conducted between 14 and 28 September 2017. See page 4 for full details of UKMTO NOTICE 002/AUG/2017.

4. The effort against piracy is truly international and breaks down traditional barriers as is demonstrated by article (a).

5. Did local Somalian communities profit for the proceeds of piracy or did they help end the problem? Article (b) refers.

6. The threat from cyber-attacks and the cost they can inflict on the shipping industry is to be tackled by Airbus Defence and Space who will partner the CSO Alliance in building a tailor-made, secure online reporting platform to help counter maritime crime. Articles (c), (d) and (e) refer.


Category: Sighting.

Description: On 28 August 2017 at 0302 UTC in position: 130012N 0431024E (Bab el Mandeb), a Merchant Vessel reported sighting 4 skiffs with 5 to 6 POB. Vessel reports seeing one ladder on board two of the skiffs, no weapons were sighted. The skiffs did not approach any closer than 0.8NM. AST showed weapons and skiffs turned away. Vessel is safe.

1. Category: NOTICE

2. Description: Combined Task Force 151, Focused Operation 14 to 28 Sept 2017

A Maritime Security Operation will be conducted in areas off the Somali Coast and Suqutra Gap between 14 and 28 September 2017. Multinational naval units, aircraft and personnel will be operating under the Turkish led Combined Task Force 151 (CTF 151) - Counter Piracy. The aims of the operation are to:

- a. Deter, disrupt and deny acts of piracy,
- b. Understand and Analyze the Pattern of Life in the area, and
- c. Reassure the maritime community through overt demonstration of presence.

Merchant vessels are invited to interact with naval ships and are encouraged to provide valuable information as requested by CTF 151.

Contributions to better understanding of Pattern of Life by merchant vessels are highly appreciated.

Mariners are reminded to navigate with caution whilst transiting this area.
