Although the HRA was removed, this does not change matters with the Voluntary Reporting Area (VRA) for the Red Sea, Gulf and Northern Indian Ocean, administered by UKMTO.

All vessels transiting the VRA are most strongly encouraged to report in accordance with BMP5 Section 6, including MSCHOA.

#### 1. Royal Navy autonomous minehunter 'Harrier' to trial uncrewed operations in the Gulf

An uncrewed boat that can search for and detect underwater threats has arrived in the Gulf, as the Royal Navy pushes towards autonomous mine-hunting operations. Harrier will work with host ship RFA Cardigan Bay on a series of demonstrations and trials, with her time in the region laying the foundation for future autonomous kit.

#### 2. Türkiye extends mandate of naval forces' mission in Gulf of Aden

Türkiye's Parliament approved a motion on the extension of the mandate of the Turkish Armed Forces naval elements in the Gulf of Aden, offshore and off the coast of Somalia, the Arabian Sea and adjacent regions for one more year as of Friday 10 February 2023.

#### 3. IMO, EUNAVFOR: Shipping must be vigilant in Western Indian Ocean

IMO Secretary-General Kitack Lim and EUNAVFOR Operation ATALANTA Commander (OpCdr), Vice Admiral Núñez Torrente, agreed that shipping needs to maintain a high level of awareness in the Western Indian Ocean and follow Best Management Practices (BMP) to deter piracy. Since 1 January 2023, the designation of the Indian Ocean High Risk Area (HRA) put in place by the shipping industry has been rescinded, due to the improved piracy situation in the region.

#### 4. 43rd Chinese naval escort taskforce officially starts escort mission

The 42nd and 43rd Chinese naval escort task forces held a rotation ceremony in the Gulf of Aden on February 5. This marks that the 43rd Chinese naval escort taskforce officially took over the escort mission in the Gulf of Aden and waters off Somalia from the 42nd taskforce. The 43rd taskforce is composed of the guided-missile destroyer Nanning, the guided-missile frigate Sanya and the comprehensive supply ship Weishanhu.

### 5. India sends legal message to Pirates

On 21 December 2022, the Indian Parliament (Upper House/ Rajya Sabha) passed the much awaited 'Maritime Anti-Piracy Bill, 2022'. It is a dedicated maritime legislation to counter the threat of maritime piracy on the high seas. Upon assent by the Indian President, it would become an Act and the Indian courts would then be empowered to exercise universal jurisdiction over the offence of maritime piracy as enshrined in 1982 United Nations Convention on the Law of the Seas (UNCLOS).
